

### FINANCIAL ASSISTANCE PROCESS

Georgia producers impacted by Hurricane Helene can apply for financial assistance grants starting in November until December 31, 2024. To qualify, applicants must meet specific criteria, including being agricultural producers with losses directly caused by the hurricane, residing in designated disaster areas or adjacent counties, and holding a valid GATE card. Applications will be submitted online through the Georgia Foundation for Agriculture website, and eligibility will be overseen by the Directors of the Georgia Foundation for Agriculture Board. Funds will be distributed to help cover losses not met by other aid.

#### **Eligibility Criteria for Hurricane Relief Financial Assistance**

- Losses Due to Hurricane Helene: Applicants must be Georgia agricultural producers who have incurred agriculture-related losses or expenses as a direct result of Hurricane Helene.
- *Disaster Area Designation:* Applicants must reside in a county or contiguous to a county declared thru disaster declaration. This designation is forthcoming as the estimated losses are determined.
- *GATE Card Requirement:* Applicants must hold a current GATE (Georgia Agricultural Tax Exemption) card issued by the Georgia Department of Agriculture.

#### **Financial Assistance Determination**

- *Application Submission:* Applications must be submitted online through the Georgia Foundation for Agriculture website by December 31, 2024. Application link is forthcoming.
- *Approval Oversight:* Eligibility will be determined by the Directors of the Georgia Foundation for Agriculture Board, based on location and the percentage of loss incurred.
- *Funds Distribution:* 100% of donations collected will be distributed to farmers impacted by Hurricane Helene.

The Georgia Foundation for Agriculture will distribute funds to eligible farmers that have suffered agricultural losses, met Foundation prerequisites, have applied for assistance and have been screened by members of the Georgia Foundation for Agriculture Board. These funds are intended to fill existing gaps not being met by the other areas of assistance. Losses covered by the Foundation assistance may include but are not limited to fencing, crop and livestock.



The recent hurricane has deeply impacted our farming communities, with many farmers facing crop losses of 50% to 100%. As the initial adrenaline fades, the reality of financial strain is setting in, leading to a rise in mental health challenges in an already challenging industry. Recognizing the urgent need to support farmer well-being, we are providing access to mental health resources, a peer support community, and financial relief grants —offering a crucial lifeline to help our farmers recover and rebuild.

#### **Peer-to-Peer Support**

- To help as we are fundraising and beyond, we're providing access to essential mental health resources, including **Togetherall**, a free, anonymous online support community specifically designed for those in agriculture. In partnership with the American Farm Bureau, Togetherall offers:
  - 24/7 Peer-to-Peer Support: Farmers can connect with others who truly understand farm life and its unique challenges.
  - Family & Individual Counseling: Access ag-friendly, confidential counseling services.
  - Financial & Legal Consultation: Receive guidance on finances and legal concerns, major stressors for the farming community.
  - Wellbeing Tools: Explore courses and resources tailored to building resilience and mental health.
  - Complete Confidentiality: Every interaction is secure, private, and anonymous.
- Through our local county Farm Bureaus, we're rolling out programs to empower these networks to support farmers within their own communities.

#### The Importance of The Relief Fund Grants On Mental Health

- Immediate Financial Relief: Grants provide faster support than government aid, which can take up to two years, helping farmers stay afloat after significant crop losses.
- Reduces Stress and Anxiety: Timely financial assistance eases the uncertainty, restoring a sense of control and stability during recovery.
- Supports Essential Needs: Funds can cover urgent expenses—repairing equipment, feeding livestock, and keeping operations running—enabling farmers to focus on rebuilding.
- Strengthens Community and Well-being: Knowing they have community support boosts morale, providing both financial and emotional resilience to face future challenges.

Together, these resources and grants can help ease the emotional and financial burdens our farmers face, providing a vital lifeline for recovery and resilience. Farming is tough, but there's strength in reaching out—and through these tools and our supportive network, no farmer has to face this alone.
